CONSUMPTION	Consumption: approximately 15 kg/m2 for 1-cm layer.
MIX RATIO	Approx.: 3,75 l of water per 25 kg of dry mixture
MIX TIME	KEMASAN 520 is made ready to use, requiring only the addition of water. Approx. 3,75 l of water for 25 kg of dry powder is needed for preparation of KEMASAN 520. For better result mix 2 bags of KEMASAN 520 with approx. 7,5 l of water in a mortar mixer.
INSTALLATION	Apply KEMASAN 520 with a trowel in 1 cm thickness on a well-dampened surface. For thicker layer apply more layers with one-day break between them. Avoid working under extreme climate and wind conditions.
